# **Toronto Hydro Construction**

Hydro-Electric System limited (THESL) is in the process of planning a significant upgrade to the electrical system in our neighbourhood.

This entire upgrade will affect the area southwest of Yonge St. and York Mills Rd. The project will be designed and constructed in three distinct phases.

### **Background:**

Two feeders power Hogg's Hollow' Feeders transport electricity in to our community. Toronto Hydro monitors feeder patterns to see if and when interruptions occur. When a feeder has multiple interruptions, Toronto Hydro evaluates how a community is supplied.

Our neighbourhood is currently supplied by a hybrid-system where the primary (high-voltage) is underground and the secondary is overhead. The primary is directly buried in the ground and the poles hold the transformers, the secondary service to your home and street lights. Toronto Hydro is planning to replace all of the existing high-voltage cables within concrete-encased ducts underground and install new padmounted transformers and flush to grade vaults to meet the supply and reliability needs of our area.

Hogg's Hollow has had more interruptions than normal over the last year. In fact, Toronto Hydro has made it a priority to be addressed immediately. Design and construction is taking place now and will take place in three phases

Overhead transformers that are currently on poles will be removed and replaced with above ground pad-mounted transformers and flush to grade vaults

For every 10 to 12 homes there will be approximately one pad-mounted transformer and 2 to 3 vaults; equipment location is based on a number of factors including property size, cable pulling and distribution loading requirements. This equipment will be installed on City property lines.

Toronto Hydro plans to have civil and electrical work complete for all three phases by December 2011

### **Project Highlights:**

Toronto Hydro is working closely with the City of Toronto (City) to upgrade this system in advance of the City's planned sewer and road work.

On Friday, September 24, Toronto Hydro met with Councillor Cliff Jenkins, the City Roads team and the YMVA to address resident concerns regarding the urgent nature of this plan and plan rollout. The meeting also addressed concerns made by residents on Donino Avenue and Donino Court that they had not been satisfactorily communicated to regarding the scope and timing of this project.

The YMVA requested a communication plan for all residents, ensuring that the planned Toronto Hydro work is communicated to and approved by all residents, and in particular those who will have transformers installed on their properties, prior to completing plans for the stages or work to occur beyond the Donino/Donino Court phase.

The YMVA has also requested that Toronto Hydro conduct a Town Hall meeting for the purpose of communicating the full details of the plan to Valley residents.

Toronto Hydro has authorized its contractor, Power Line Plus, to begin designing this project.

### **Project Phases:**

Phase 1 – Ongoing

Streets included: Donino Ave., Donino Crt. and Donwoods Dr. at the intersection with Donino Ave.

Civil construction: September 2010 – January 2011

Electrical: February

**Phase 2 and 3:** TBC, pending Townhall meeting and street-by street consultation.

### **Important Notice Regarding Electrical Poles:**

While the transformers will be removed from poles and placed on the ground, existing electrical poles, which feed electricity from the underground cables to your home, will not be removed unless you, and those neighbours who share these overhead connections with you, agree to bury the services to your houses. Please read below information from Toronto Hydro...

# Putting your secondary services underground...

Some of you have asked for your service wire – the one from the pole to your home – to be put underground during this project. Toronto Hydro is making provisions for this to be done easily by extending our duct to your property line. In order to put your service underground, you will require an electrician to extend a duct from your meter base to the front of your home, where it would connect with ours.

Please note, one pole feeds about 4-6 homes, if you and your neighbours choose to go underground, this may eliminate the need for this pole.

#### Steps:

1. Call your Toronto Hydro Customer Connection and Maintenance (CCM) representative, Kris Velss, and initiate this request. (416) 542-7882.

2. Speak with your neighbours about their interest in participating

3. Source individual or group rates from a qualified electrician

# <u>Yonge York Mills Channel</u> <u>Maintenance Program</u>

The Toronto and Region Conservation Authority (TRCA) have retained Stantec Consulting Ltd. (Stantec) to commence the first stage of a channel maintenance plan for the West Don River. Stantec completed a hydraulic assessment and channel maintenance study of the West Don River from Yonge Street to a point approximately 1.7 km downstream at Knightswood Road. The intent of the study was to develop an understanding of the existing flood conveyance capacity of the channel through the study area, assess the structural capacity and "geotechnical integrity" of the various hydraulic structures and channel lining materials, such as the concrete slabs and gabion netting lining the river banks.

The field assessments have been completed and a 5 phase maintenance plan has been developed for the Study Area. The maintenance plan will generally include the removal of accumulated sediment, woody vegetation and debris from within the channel throughout the Study Area. In addition, the maintenance plan will also include spot repairs to the existing concrete channel lining between Yonge Street and Donino Avenue, repair to the concrete drop structure at Donino Avenue, and replacement of several concrete panels just downstream of Yonge Street.

The study results and proposed plan were presented to the Valley residents in April 2010.

The tentative maintenance plan is as follows. TRCA has funding in place to commence Phase 1, which is coupled with the sewer work the City is proposing.

There are three river "reaches" in this project: **Reach #1** (Yonge Street to Mill Street), Reach #2 (Mill Street to Donino Avenue) Reach #3 (Donino to Rosedale Golf Club).

### Phase 1 (Fall 2010)

- Replacement of Concrete Slabs (Reach #1)
- Concrete Drop Structure Repairs at Donino Avenue (Reach 2)

### Phase 2 (Fall/Winter 2010–2011)

- Vegetation/Debris removal (Reach #1, #2, #3)
- Concrete spot repairs above water (Reach #1, #2)

### Phase 3 (Late Summer/Fall 2011)

• Sediment removal (upstream portion of Reach#3)

### Phase 4 (Late Summer/Fall 2012)

• Sediment removal (downstream portion of Reach #3)

#### Phase 5 (Late Summer/Fall 2013)

- Sediment Removal (Reach #1, #2)
- Concrete Spot Repairs below water (Reach #1, #2)

All work is to occur between August 1 and March 14<sup>th</sup> of any given year to be in accordance with the allowable warm water and fisheries construction window and bird nesting periods.

Along the river banks substantial vegetation may be removed, including some trees that have grown in the river and on its banks in the past 15 years since the channel was last maintained.

The intent of the maintenance plan is to maximize the channel's capability to move water in a safe manner, to maintain structure stability and to extend the life of the channel.

## **Roads and Sewer Infrastructure Upgrade**

Discussions with the City continue on the upcoming work on the road improvement and Stormwater Management project.

As of October 1st, work is scheduled to begin on the second phase of the project in April 2011.

This will allow for the conclusion of the Toronto Hydro work discussed above.

We have urged the city to coordinate the completion of the work on as large a section of the valley roads as is feasible during this phase, so that we do not experience prolonged disruption

We are still working with the city on finalising the design for Plymbridge Road, including the necessary road widening and tree consultation.

Discussions with respect to traffic calming are scheduled to begin upon completion of the first section of the project.

# Partial Parking Lot Conversion to Park

### **Background:**

In 1997, the former City of North York Council approved the acquisition of the Jolly Miller property located at 3885 Yonge Street and the development of the northern portion of this property as a municipal parking lot in order to generate revenue to aid in the recovering the acquisition costs. Having now recouped those costs, Council adopted a staff recommendation, this year, to convert the easterly portion of the Toronto Parking Authority Lot back into green space. This will reduce the number of parking spots by half.

The park design is based on a budget of \$425K, which includes demolition of the current parking lot and complete park development. The Toronto Parking Authority (TPA), who will also be responsible for construction, will provide funds.

Our past YMVA Board member David Payne is to be thanked for his diligence in working with the City to ensure that the land is to be returned to parkland.

#### The Park Plan:

On Wednesday, April 21, 2010 an open house was held at the Agricola Finnish Church, in order to allow the Valley residents to view the park proposal.

The site to be changed to parkland is .57 hectares in size and is located west of the West Don River. Plans have been prepared by City staff to develop the current parking lot into "passive" parkland. The new park will consist of pathways, lighting, sitting area, wildflower meadows and tree plantings.

The sitting area will be constructed to appear as a Miller's cabin "ruin", reminiscent of one of the historical gristmills, which populated the valley from the early 1800's.

"With three mill sites in York Mills the sound of running water over the water-wheels, the buzz of the saws cutting logs, and the noise of the stones grinding the grain echoed throughout the valley each day from 1804 until 1926. In this business district the landscape was dotted with houses, out-houses, cooper's shops, and blacksmith shops behind the tavern east of Yonge and through the valley west of Yonge..." (Pioneering in the North. Patricia W. Hart)

An extensive flower, tree and shrub-planting plan will ensure 4 season shows of shrubs, trees and spring and summer meadow flowers. Mixed, deciduous trees will buffer the meadow. Plants will also support the wildlife in the area. A community planting has been recommended for the valley residents. Notification will be made once the construction plan is complete.

Interpretive signage will provide historical information regarding the Mill site as a significant area of industry and community. Signage will also include information regarding the wildlife in the valley and how the river system is used as a significant migration and feeding system for birds and other wildlife.

### Park Design and Approvals:

The design phase of this project is near completion. Final construction details for the park are underway and include the lighting, overall planting design and choice of hard landscape materials.

Two environmental assessments have been completed to ensure that the soil underneath the parking lot is suitable for the park development. The drawings have been submitted to the Toronto Regional Conservation Authority for approval, with anticipated approval in fall 2010.

Toronto Parking Authority Board Approval is anticipated for February 2011.

Construction tendering for park and parking lot will occur in January 2011. Construction of the park has changed from the fall of 2010 until the spring of 2011. It has been pushed from the fall of 2010 to the spring due to the approval process required to award the contract to the Environmental consultant and TTC drilling approvals.

Parking Lot construction development will commence in May 2011.

# Development of the NW Corner of Yonge & York Mills (4050 Yonge St.)

On June 3, 2010 Councillors Jenkins and Stintz hosted a well-attended public meeting to discuss the proposed 4050 Yonge Street development. Following up on that meeting, the YMVA and other area ratepayer groups have met twice more with Build Toronto and their representatives to discuss the proposal as it has developed. The YMVA will be meeting with Build Toronto at least once more before a statutory public meeting is held sometime after the municipal election. We expect that the public meeting will take place before the end of this year. The city will send notification of the public meeting to all Valley residents by mail.

Over the course of the consultations many issues, both large and small, have been discussed. The following is a summary of the YMVA's views on some of the major items up for discussion at present:

We are encouraged that the architect chosen to design the proposed project is KPMB, an internationally respected architectural firm headquartered in Toronto.

We are concerned that the proposed building's height exceeds the property's zoned height restriction. The area of the proposed building that most exceeds the height zoning is a clear glass chimney designed to make the building more energy efficient. Given that the chimney is clear and relatively modest in size in comparison to the overall building, this may not be so much of an issue. However, we have not seen a model of the structure to fully evaluate its impact. More concerning, perhaps, is a large area in the middle of the roof that exceeds the height zoning by several meters. Although this area is stepped back from the edge of the building, and even though it will be a green roof, from an aesthetic point of view, we believe that the additional height in this part of the building will make the building appear too high from a number of vantage points and it does need to be reduced. Additionally, we are concerned that if the city itself does not follow its own, site-specific height zoning that was imposed on this property by special by-law, enacted by council approximately 11 years ago, a troubling

precedent could be set. All area ratepayer groups agree on these points.

It looks as if the TTC is the likely tenant for the proposed development. Under this scenario, the building would become the TTC's new headquarters. As long as the TTC and the City are able to make a financial case to taxpayers that this move makes sense, we are inclined to see a TTC tenancy as a net positive. This is primarily because a higher than average percentage of TTC staff use public transit to get to work and therefore at least half of the proposed parking garage would remain public parking for commuters. If private tenants were to occupy the building it is more likely that little, if any, public parking would remain on the site. That being said ratepayer groups have commented that chronic financial challenges at the TTC have meant that the TTC has done a very poor job of maintaining its various physical structures in recent years. Concern has been expressed that should the finances at the TTC continue to be a problem, this site could become similarly poorly maintained.

We have concerns about the amount of public parking that will be available in the new building. Under the current proposal the total number of parking spaces will be reduced from current levels by about 30. Even more significantly, the number of public spaces will be less than half of what is available now since the tenant will require a significant number of the available spaces to accommodate the parking needs of its visitors and the anticipated 1300 employees that will work in the building. Every ratepayer group that has provided input has expressed concern on this matter. To

counter these concerns, Build Toronto stated that research has shown that 70 per cent of current parking lot users are not commuters but are actually staff that work at York Mills Centre (located on the NE corner) who are taking advantage of the lower parking fees in the Green P lot which run about <sup>1</sup>/<sub>2</sub> the cost of parking in the York Mills Centre. Build Toronto believes that once the parking fees are more comparable, York Mills Centre staff will park in their own building. We have not yet independently verified this statistic. In any event we have requested that a cost benefit analysis of adding a third underground parking level be done as we do see this as an important commuter parking lot where the available parking needs to keep pace with the expected growth in TTC ridership over the coming years.

Another concern is related to traffic flow in and around the intersection. The parking garage needs to be designed to absorb incoming cars quickly so as not to cause further slow downs in an already congested intersection. We have emphasized that the parking lot design cannot be an afterthought.

We have some concerns about a potential increase in bike traffic once the new structure is in place. In concurrence with new city standards, the proposed building includes parking for 177 bicycles. If there were to be a significant increase in bike traffic, we are troubled about the potential for problems for the cyclists, vehicular traffic and pedestrians along hilly Yonge Street and York Mills. Of particular issue is that many high-speeding cyclists tend to use the sidewalk to traverse this area. We have asked that the traffic study be expanded to include bicycle traffic.

We have seen a few small drawings of the proposed structure but they do not give a clear enough idea of what the building would look like, what colour it is or what materials it would be made from or how the structure would sit on the site and therefore it is difficult to give a meaningful assessment of the design at this point.

The design does appear to have some strong points. For example the area of the building that sits at the corner of Yonge and Wilson appears to have a well defined entry that appears to be reasonably well detailed with an open and airy feel. However, the run of building along Wilson appears to be too imposing, an issue that may be compounded by a fairly shallow setback from the road. We recognize that the architect has some challenges here as this is the only side of the building that can accommodate the parking and delivery entry and exits and the natural topography means that the start of the "Wilson hill" is a bit of a problem as are Conservation Authority restrictions. However, we believe that more can be done to improve the design along this side of the structure. In general we are somewhat concerned that if exterior colours and materials are not chosen with the context of the surrounding natural space in mind, the building will not harmonize with the natural surroundings. We do not believe the building should be designed to stand out by itself. It needs to complement the area around it.

As part of its environmentally friendly design, the proposed building is expected to have computer regulated window louvers that would control passive heat and light from the sun depending on various conditions. No image of the building with louvers in place has been made available which will be necessary to properly assess the building's appearance.

It may also be of interest that the city is also seeking input on the building's design from other sources. Where it is anticipated that a building will be an important one in the city, the city may direct that a Design Review Panel (DRP) be convened to review the plan of a building during the design process. A DRP is an impartial group composed of a number of experienced and well regarded architects who volunteer to take the time to understand the site and critique the proposed building's design. Because the city acknowledges that the Northwest corner is a location with unique features, is a high profile intersection and because this would be Build Toronto's first development, the city did request that a DRP review the architect's plans. The DRP meeting to discuss the Northwest corner was held on September 28. Overall the design was well received by the panel. The panel did make recommendations with regard to the south facing facade and encouraged the architect to continue to work to add some additional interest to that portion of the building. They also encouraged the architect to work to ensure that the ground floor was a little more transparent so some of the natural features and a proposed dining patio on the north side of the structure could be seen and appreciated from the south side. A passing caution was given that the building does need to harmonize with the rural aspects of the intersection. They also noted that the architect needed to provide images of the structure with the louvers in place.

Following the DRP meeting and in response to input from the community we expect that some changes to the design will be made before the next public meeting. We have advised Build Toronto that larger, more detailed drawings of the updated proposed structure will need to be made available for public viewing in order to more adequately assess the impact of the structure. Also, samples of the proposed building materials and a model of the structure, including pre-existing features of the surrounding area, need to be brought to the public meeting.

Look for an invitation to the public meeting from the city sometime after the municipal election. The YMVA will also keep you posted, as needed, in upcoming newsletters and emails.

There have been five reported break-ins since our last newsletter:
