## **Roads and Traffic Committee:**

In the April newsletter we reported that construction for the road and stormwater management project was expected to commence in late summer in Priority Area A. Clearly that did not happen. Soon after publication it became apparent that there were several outstanding jurisdictional and engineering issues that The City needed to deal with before construction could begin.

Among other things, the Toronto and Region Conservation Authority (TRCA) expressed concern about the increased quantity of storm water that will be discharged directly into the Don River once the drainage improvements are in place. As a result, the TRCA approval process has required more information from The City and is taking longer than expected.

Additionally, there are several locations in Priority Area A where the size of the pre-existing drainage pipes that our upgraded system was to connect into, are too small. For example, on Donino Avenue, the outlet pipes are built right into the structure of the Donino Avenue Bridge. Since these pipes cannot be expanded, new pipes will have to be run in a different location. They will likely go underground through the corner of

the adjacent park. This change requires additional engineering as it will involve cutting into and repairing the concrete wall built along the river. There are other various piping challenges in other parts of Priority Area A that City engineers have to resolve. Although these challenges can be overcome, they involve more paperwork and more engineering and, therefore, more time.

The bottom line is that, as of this writing, it is doubtful that any work will start until next spring at the earliest.

Needless to say we were concerned by this news and we immediately requested a meeting to bring together Councillor Jenkins and City Staff. At that meeting we emphasized that while we are committed to ensuring that this project is done well, City Staff has a responsibility to Valley residents with water problems to keep the project moving forward on a timely basis.

It should be made clear that this was not just a meeting organized so we could express platitudes. It was an action oriented meeting where we reviewed in some detail outstanding issues and their potential solutions, we spent time troubleshooting possible bureaucratic slow downs in order to minimize them, and we developed an agreed upon action list for City Staff. We are currently following up to determine the status of the items on that action list.

We recognize that for many of you the need for road and/or stormwater management improvements is not urgent and, for others, not even desirable. However, the YMVA is concerned about the almost 25% of Valley residents that have some form of water problems on

their property. These problems are particularly acute for some Priority Area A residents who, under current conditions, regularly experience flooded basements and flooded properties when there is even a modestly significant rainfall. These problems can only be resolved by implementing a neighbourhood-wide stormwater management strategy and the YMVA supports the timely implementation of those improvements.

Among other things, in order to do what we can to keep this project on track for a spring start and to keep the neighbourhood informed, the YMVA has made the following requests to which The City has agreed:

- If needed, The City will subdivide Priority A into sub geographic areas so that as outstanding items are resolved, each sub area can go to tender and construction can begin without having to wait for all issues in Priority A to be resolved. Sub Areas are:

  Donino Avenue/Donino Court, Campbell, Plymbridge/May Tree, and Doncliffe/Mt.

  Pleasant/Forest Glen.
- City Staff will itemize significant outstanding issues and will put together a new project schedule. This information will be communicated to the neighbourhood as soon as possible. Look for a letter from Councillor Jenkins' office in the coming weeks that will include these particulars.

We have asked The City to continue on a timely basis with its commitment to host street by street on-site meetings with residents to present the proposed road and curb designs as each street's designs are ready for review. This will help keep the project moving forward since once residents have had an opportunity to comment on the road designs, the designs can be finalized. This means that tenders can be put out immediately once the technical problems relating to stormwater management have been dealt with.

In the meantime the YMVA continues to keep on top of the issue, continues to work with The City to help resolve problems where possible, and generally pro-active with The City to ensure that this project is kept top of mind.

There were five break and enters reported since the last newsletter. These occurred in houses on Cole Millway, Donwoods Drive (2), York Valley Crescent, and Campbell Crescent.

Jewellery was stolen in 3 cases; laptop and Playstation were stolen in 3 out of these 5 cases. There were two incidences of forced entry and one case when the unknown suspects walked the perimeter of the house and cut all the outside wires, then the inside wiring to the home alarm system.

On a September evening at around 11pm, a teenage victim was attacked by five unknown suspects with a baseball bat while walking and talking on his cell phone in York Mills Valley Park. Once the suspects emptied the victim's pocket and took his cell phone, wallet with his ID, they walked away.

The flower beds are being tended to by a new City staff gardener, Mary-Ann, and if you see her toiling away say hi, she's doing a great job. We are also working with Christine Rosenthal to replace the

### **Gypsy Moth:**

Gypsy moths plagued a lot of us this summer. The City has provided us with information on what we can do next year. This can be found on our website <a href="https://www.hoggshollow.net">www.hoggshollow.net</a>. Thank you to Steve Neil for maintaining this website.

Over the past several summers Gypsy Moth infestations in the Valley have been particularly troublesome. Homeowners can help reduce Gypsy Moth populations by seeking out and destroying their egg masses. Late fall and winter are particularly good times to look for egg masses as plants have died back and leaves are off of trees making for better visibility.

Egg masses are easy to identify. They are a buff-coloured teardrop shape about 1-1/2" long. They can be found in the grooves in bark, underneath branches, behind signs, in downspouts, underneath patio furniture, in firewood, on swing sets – you name it.

There are several ways to kill an egg mass. One of the easiest is to use a knife or other implement to scrape the mass off. Then place it in a container and fill with soapy water and soak for 2 days. Once the nest has been thoroughly soaked it can be discarded. Each egg mass that is destroyed can eliminate up to 1,000 Gypsy Moths!
