# **Stormwater Management and Road Improvement Project**

#### **Sanitary Sewers:**

In preparation for the stormwater management and road re-construction project, the city began rehabilitating our aging sanitary sewer lines earlier this year. Although technically this is referred to as a "no dig" method, to many of us laypeople it would seem that there has been a fair bit of digging going on. That being said, we have been told that this is a state-of-the-art project which involves a lot less digging than would normally be required by this type of task. More typically, traditional sanitary sewer rehabilitation projects require that large trenches be opened up from the road right up to each house. In our case, D. M. Robichaud (the contractor) is using a method which requires that a "modest" hole be dug in order to install a new sewer cleanout on city property in front of each home. The location of each of these cleanouts is indicated by the blue access pipe that is currently sticking out of the ground in front of most homes. At present most of these cleanouts have not yet been passed by the city inspector and therefore most residents still have bare patches of sand or gravel around a raised blue pipe.

Over the coming months, underground photos of the rehabilitated pipes will be reviewed and inspection work will be done by the city. When the cleanout passes inspection by the city the location of the cleanout will have been mapped and the blue pipes will be cut down such that they cannot be seen above ground. Once that work is complete lawn or driveway repairs will be done.

We were originally told that this project would be finished this fall before winter set in. However, (and don't shoot the messenger) we have just been advised that it is going to last well into next year, possibly as late as June. This change in timeline is new information that only came to light when doing research for this newsletter. It is concerning that Toronto Water (the folks responsible for the sanitary sewer rehabilitation) did not proactively advise our neighbourhood or their own colleagues in Technical Services (the folks responsible for the road and stormwater management project) of this significant change in timing.

As of this writing we are setting up a meeting with YMVA reps, Councillor Jenkins, city staff and D. M. Robichaud to address this unacceptable delay, the poor communication on the part of Toronto Water, and other issues related to some isolated problems stemming from the sanitary sewer rehabilitation project. Among other things we will be discussing strategies to tighten up and bring discipline to the schedule, we will be getting clarification as to what residents can expect over the coming months as the project proceeds and we will be clarifying how a delay might affect the stormwater management and road construction project. Additionally

we will be making clear our expectation that the two city offices involved in our neighbourhood's two intertwined projects (sanitary sewer rehabilitation and stormwater management/road construction) will establish procedures to effectively communicate and coordinate with each other. We will also request that the city and/or D. M. Robichaud send out a mailer to update you on a realistic time line and to advise what you can expect for the remainder of the sanitary sewer project. ### <u>Stormwater Management and Road</u> <u>Construction Project:</u>

Continuing on the theme of delayed time lines... As is obvious, road and storm sewer construction has been delayed yet again. The reasons for the delays are various including Conservation Authority issues, right of way issues, pipe capacity issues and the unanticipated discovery of a large holding tank near the top of the golf course which has brought the Ministry of the Environment into the picture etc. We are sure you are as tired of hearing about the delays as we are in the telling. However, we continue to prod the city on this project to keep things moving. We are cautiously optimistic that storm sewer work will begin later this fall in

areas that have the most problems with stormwater run off.

We do pass your feed back to The City and we have made The City aware that the delay in construction is increasingly having a negative effect beyond Priority Area A. For example, these delays have contributed to the ongoing deterioration of many neighbourhood roads. Since the start of construction has been considered "imminent" for several years now, the city has been reluctant to invest in substantial road maintenance. Therefore many of our roads are in increasingly bad shape. Also, standing water problems, especially in parts of Priority Area B, have been exacerbated by increasingly poor road quality and this year's high volume of rain.

Since the start of the project has been so significantly delayed and since residents outside of Priority A are increasingly affected by water problems and road deterioration to various degrees, we have been discussing with The City the possibility of adjusting time lines for the entire project by effectively folding the project into two rather than three priority areas. That is, they would more or less eliminate the concept of Priority Areas A, B and C as was originally conceived i.e. originally A was to be completed, then B would follow one to two years after the completion of A, and C would follow one to two years after that. This change would not hold up the start of construction in Priority Area A. Priority Area A will get started first since it is a priority in terms of resolving the more urgent water problems. However, we have given them a proposed a timeline that would see portions of Areas B and C get started at the same time or very near to the same time after "A" areas are started. Our primary goal is to address

water and road problems on basis of highest need while limiting the amount of time the neighbourhood has to live with major road construction. The City agrees that the time-lines should be revisited and has had a staff meeting to review our proposal. The YMVA will be meeting with the city in the near future to discuss this and other project related issues. At that time we will also be requesting that The City updates area residents on this project through a special written communication.

We should also note that in addition to working with the city on road design issues and logistical issues on the macro level, we also work with the city on logistics as they relate to the individual resident. Once the city is ready to proceed with construction on a particular street, residents will get the information that they may need to plan for construction e.g. how landscape features, sprinkler systems etc. in or near the construction zone could be handled etc.

Landscape Architect, Mark Hartley, has donated time to provide suggestions and plant lists to The YMVA. YMVA Beautification Chair, Christine Acconcia, is also working with the City to develop ways that they will support our beautification efforts so that our fund's dollars will stretch as far as possible. At present two areas are being focused on for beautification: The Millstone Parkette and the area around the historic school wall at Mill Street since these areas will not be affected by road and sewer construction. A modest amount of work will be done in these locations this fall with more to be done in the spring. As the road work is completed other beautification opportunities will be considered. A post-construction priority will be in the area around the "Loblaw" wall.

#### Get a Free Tree!

Urban Forestry Services plants trees on City owned street allowances fronting residential properties for free. For more information go to

For an additional fee residents can order a larger tree. The City will provide advice on tree choice. Even if you have a mature tree on your front lawn, The City suggest that residents order a young tree that can get growing so it will make a nice, full replacement tree if something happens to the older tree.

#### Interested in a tree for your backyard?

Contact LEAF (Local Enhancement and Appreciation of Forests) which is a local non-profit group dedicated to improving Toronto's urban forest. They offer Toronto residents subsidized backyard tree planting.

The service includes on-site advice on appropriate species and planting location, a 1.2 to 1.8m tall native tree, and the planting service. Native shrubs are also available.

#### Filming in The Valley:

Several homeowners who have had films shot at their residences have arranged for the movie companies to donate to the YMVA to account for the inconveniences caused by the shoots. #### **Noisy Airplanes:**

There is legislation in place that is designed to limit the times of day that aircraft can fly over residential areas and that requires aircraft to remain at specific altitudes when in our area. The goal is to limit excessive airplane noise. Often, however, these rules are disregarded by aircraft controllers and pilots which can lead to unreasonable aircraft noise. If you are bothered by an excessively noisy plane, we encourage you to make a noise complaint on the Greater Toronto Airports Authority (GTAA) web site. All complaints are investigated and over time it will help if our neighbourhood

is a squeaky wheel (pardon the pun). Simply go to <a href="www.gtaa.com">www.gtaa.com</a> then click on the grey "Community Relations" tab, click on "Noise Management" and once there look for "Register a Noise Complaint".

# <u>Ravine Bylaw – Head's up to the new rules!</u>

Over the summer there were a few issues around the new ravine bylaws and cutting of trees and shrubs. If your property falls into the area defined as part of the ravine by the city, you are not allowed to remove any trees or shrubs without permission from the city – regardless of their size. The 10" diameter rule does not apply to ravine properties. The bylaws came into effect in 2002 to help prevent erosion and to try ensure soil stability. They were recently updated. I am happy to report that there have been no valley incidences reported to me since the last newsletter. In a conversation with Wayne Pierce, the crime analyst for 32 Division, he reported no increase in Break & Enters or car theft, not just Hoggs Hollow, but surrounding areas, in the last quarter. He recommended GPS units and equipment

should be out of sight when not being used and not to lock glove compartment/consul boxes so that if there is a B & E, thieves don't break it open.

Purse snatching is on the rise. Officer Pierce said people walking slowly from subways through the park or even walking on our streets with groceries (hands occupied) could be an easy target. He felt our park lighting could be updated a little to make it safer. A reminder also, to leave front and back porch lights on. This acts as a deterrent.

Following up on a request made at last year's Annual General Meeting, on a rainless summer evening, a few neighbours (including YMVA members) conducted a review of the status of our Valley's Street lighting. A total of seven city streetlight bulbs need to be replaced. Once this has been taken care of, we believe we will have a better balance between community safety and our much cherished rural character.
