PRESIDENT'S MESSAGE

At the time of writing, we are firmly in the grip of winter, with the Valley looking its rural best under a blanket of snow.

At the Annual Meeting in December, I indicated that I foresaw the Storm Water Management and Road Improvement Study as being the major matter with which the YMVA would have to contend this year. We recognize that it is desirable to implement measures to control flooding and that this will involve repaving our streets. However we would like this to be accomplished in a way that does not change the rural feel of the Valley. Early on in the study process, it was suggested that sidewalks would be installed as part of the repaving. The YMVA conducted a survey and established that Valley residents were overwhelmingly opposed to sidewalks where they don't now exist. The planners listened and scrapped the sidewalk proposal. Community action can make a difference! We have also had success in having some proposed road widths reduced from those originally proposed, saving trees which would otherwise have to be removed. At the last open house, pictures were shown of proposed street designs consisting of blacktop bordered by white rolled curbs. Most of us thought that this looked like a suburban subdivision. It was also suggested by the Toronto Fire Department that Valley streets become "no parking". This seemed an inappropriate restriction to us, as street

widths were not being altered. Norman Hardie, Leanne Lewis and I met with our Councillor, Cliff Jenkins, and the Study staff in January to discuss these two issues. At the next open house, tentatively scheduled for early April, the Study people have indicated that they will present alternative street toppings and curb treatments. Cliff Jenkins is sympathetic to our position with respect to parking and will see what can be done, but this is essentially a separate matter from the Study and is a battle we may have to fight in the future. Stay tuned.

Construction at 45 York Mills, the old York Mills School site, has commenced. Because of the nature of the soil, the first phase of construction involves adding soil and compacting. Unfortunately, the compacting activities have caused excessive vibrations affecting homeowners on Campbell Crescent, York Ridge Road and Old Yonge Street. Cliff Jenkins has been active in this matter as have City inspectors and other staff all of whom attended a meeting with affected residents on February 9th.

On a lighter note, hopefully we will have a few more weeks to enjoy the Brookfield Rink and then we can look forward to another lovely spring in the Valley.

Notice of Important Meeting Tuesday, March 8, 2005 9:30am Toronto City Hall 2nd Floor Committee Room

Background:

In 1997, the City of Toronto purchased the Jolly Miller parking lot lands. At that time,

a promise was made that once the purchase price was paid for out of parking lot revenues, the land would revert back to parkland.

Now there are stirrings at Toronto City Hall that have given the Development Committee grave concern. There is talk of reneging on this commitment, or worse, developing this land.

On Tuesday, March 8, 2005 at 9:30am, in a 2nd Floor Committee Room, there will be a presentation of a report prepared by the City of Toronto. **We need all available members of the YMVA to attend that meeting, to ensure that our voice is heard;** we do not want this property to be developed, nor do we want it to be a parking lot in perpetuity.

Councilor Jenkins has requested that I provide him with a list of names of people that are able to attend and I would ask that you contact me, on an urgent basis, to confirm your attendance at said meeting and to allow an opportunity to further brief everyone.

This is a significant piece of property and it is no secret that Toronto City Council is looking for money. City Council must see that we are an active association that is committed to preserving the character of the Valley. Please join us at this very important meeting.

Traffic Committee Update

The YMVA Annual Meeting, held on December 4, 2004, again provided a forum for a good discussion of traffic issues and concerns in the Valley. Residents are clearly in favour of much more enforcement of the rules of the road in the Valley,

particularly with respect to excessive speed and failure to observe stop signs. Councillor Jenkins offered to be involved in urging 32 Division to attend more regularly in the Valley to address these concerns. It has proven difficult to get much traffic enforcement in the Valley, but we have established connections with two sergeants at 32 Division and will be following up with them, in conjunction with Cliff Jenkins to insist on more enforcement.

When 45 York Mills Rd. is occupied, there will be an exit onto Old York Mills Road, but there is supposed to be a no left turn sign there, so as to prevent traffic from entering the Valley to cut through to Old Yonge Street or to get to Mill Street. Such signs, to be effective, must be the subject of significant enforcement and we will be requesting that. Again, Councillor Jenkins offered to lend his support to getting enforcement there to prevent additional "cut-through" traffic from residents of 45 York Mills Rd.

We again discussed the process of individual streets or sections of streets requesting traffic calming measures, as several residents wish to pursue this with the city due to excessive speed on their street and safety concerns for pedestrians, cyclists etc. Specifically, the residents of Campbell Crescent and Plymbridge Road expressed an interest in having traffic calming introduced onto their streets.

One Valley resident reminded the assembled group of the importance of walking against oncoming traffic, instead of having your back to the traffic. This is a very good point to remind people about, especially the children. It is much easier to react to a vehicle approaching on the same side you are walking on than if you have your back to the vehicle.

Hillcrest School traffic issues were again discussed, and there are continued concerns about the congestion at drop off and pick up time, and impatient drivers who do not want

to wait until they are signalled to proceed. In addition, many parents dropping off or picking up children have been observed using excessive speed while coming into the Valley and leaving. The Valley executive was requested to again communicate the residents' concerns and ask the school to communicate to the parents of the schoolchildren to be cognizant of the speed limit and to observe it. Another concern expressed by residents in the vicinity of the school is the pollution caused by lengthy periods of vehicle idling while waiting to pick up or drop off children. Some residents have approached the idling vehicles to request that they shut off their engine while waiting to pick up or drop off children, but have been met with less than polite There is a by-law regarding responses. maximum length of time a vehicle can be left idling, and we will be looking into the enforcement of that by-law in the vicinity of the school. On a positive note, in response to a request from a resident in the vicinity of the school, we contacted the City and Councillor Jenkins office and arranged for a "School Children Crossing Sign" to be erected on the side of the road at one end of the school to go with the sign that was already at the other end of the school.

Ongoing issues being reviewed and pursued include: 30 km/hr speed limit in all traffic calmed areas, the advanced green for westbound drivers turning left at York Mills Rd to go south on Yonge St. (to encourage drivers to make their left turn at the major intersection, rather than cut through the Valley over to Mill Street and go south on Yonge from there- this has apparently been budgeted for 2005 according to Pam Spence), the "Watch Your Speed" trailer is to be scheduled for the Valley, Old Yonge Street speed humps (approved but not installed), monitoring construction vehicles for 45 York Mills Rd to ensure they do not use Campbell Crescent and the possible reconfiguration of the stop signs at Donino Court and Donwoods Drive at the bottom of the hill.

This will be my final report on traffic issues in the Valley, as directors Norman Hardie and Leanne Lewis will be taking over the traffic portfolio. I will continue on the board in a different capacity. I will repeat my oft-stated request: please slow down, observe the stop signs and consideration for our neighbours and others using the streets of the Valley. Make it a safe place for the children and everyone else who enjoys walking in our picturesque setting.

VALLEY CRIME WATCH

Fortunately we have had a relatively quiet period on the crime beat. However, there was an attempted break-in in September, 2004 on York Valley Crescent. The locks were tampered with, but it went no further than that. Also, a car was stolen in the neighbourhood when it was left unattended while being warmed up.

The Toronto Police Service has asked us to remind you of the following:

Never start your car and leave it running unattended for even a few moments.

Always lock valuables in the trunk or keep them out of sight.

Inform police of any activities or vehicles that look suspicious to you.

Leave an exterior light on so that you are not walking up to your door in the dark when arriving home.

Be aware of the possibility of a 2nd story break-in. There have been several in 32 Division. The suspect uses a ladder or patio furniture found in the victim's yard, a neighbour's yard or construction sites to access second story windows or doors. They know homeowner's often leave second story access points unlocked and unarmed. In some cases, the homeowners were home eating dinner or watching tv.

Please arm and lock second story entry points, even when you are at home. Also, please secure your ladders.
